

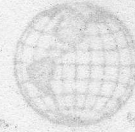

Connections of the Mormon Church, National Association of  
Evangelicals, Trans Pacific Enterprises, 1957, to uranium export.  
Distribution of over 1 million tons of uranium to Australia.  
Role of LBJ, Mrs. Johnson, to NASA, Uranium shipments.

"AUSTRALIA WILL SEND URANIUM TO FINLAND"

Uranium to be sent, via Australia, to "Japan, Iran, Phillipines,  
Sweden, and Austria".

"Australis has a fifth of non-Communist world's known uranium".

Mae: We are arming through the  
back door. Ship to Australia, let  
them distribute. Australia the  
source of supplies to Hitler's  
Antarctica.

## Obtained from the FBI

" June 26, 1945. John Abt, assistant Attorney General, Anti-Trust  
Division, Department of Justice. Husband of Jessica Smith, editor  
of Soviet Russia today."

The only attorney Lee Harvey  
Oswald advised to "help him"  
after his arrest Nov. 22, 1963.

"Feb. 23, 1949. Felix August Inslerman, identified as Felix,  
was one of Chambers photographers for his underground apparatus.  
A 35mm Leica camera was found in Inslerman's possession. The  
FBI had access to the pumpkin microfilm, concluded the two rolls  
were exposed by Inslerman's Leica camera."

"Feb. 18, 1949. David Whittaker Chambers, admitted homosexual,  
will provide names, date, places involved along these lines with  
Chambers or with others."

"Mr. Crane believes Chambers said their chief had been called  
"Felix". It will be recalled that Alfred Tilton's predecessor  
was known as Felix. Crane was introduced to Chambers by a man  
described as the Chinaman. The contents of documents were signed  
by George Messerschmidt, who Chambers described as being 'absolutely  
clear on the Nazi question'."

"Crane recalled the first name of the Italian mentioned as Guido".
