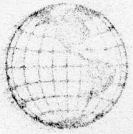

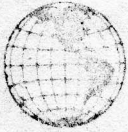
1 Rep.Sawyer,Michigan.Took Gerald Ford's seat when Ford became President. Fat chance of his exposing Ford's CIA,FBI links.

Robert Blakey's Assignment

- 1) Use scientific evidence to support original findings.
- 2) Silence the mounting critics, they are going too far.
- 3) Turn the Gallup Pole around, so U.S. flag can fly again.
Make us proud of our Federal Agents. End suspicions.
- 4) Put mass of blame on J.E. Hoover, for hiding "Hosty letter",
and Allen Dulles, for "not telling CIA plans to kill Castro".

know until their Oswald files are out", while we destroy and
lock up our evidence and testimony.

WORKING BAG OF TRICKS, SOME OLD, SOME NEW

Secrecy from the start

Refusal to examine "critics" documents and evidence.

Not call important witnesses.

Ask the wrong questions of those who were called.

Accept perjury, and testimony from already proven liars.

No accountability for evidence lost that would alter conclusions.

No admission that major witnesses, named, were dead.

Time limits imposed on questions, entire investigation.

No cross examination of witnesses by anyone knowledgable.

Ignore important evidence of their own teams of conspiracy.

Diversions away from Pentagon, CIA, Navy Intelligence, FBI.
