FRED LEE CRISMAN

Obtained from Tom Adams, P.O. Box 1094, Paris, Texas. 75460  
The man who accompanied "the tramps" away from Dealey Plaza.

Worked with T.E.Beckham, Tacoma, Wash.  
Transferred \$700,000 or \$800,000 to Miami, 1966.  
Served with Beckham in Merchant Marine.

Connections to U.S.Association of Special Police, 37 E.28th St.  
N.Y.10016.

Set up schools to train future police officers.  
Hosted a night-time talk show, alias John Gold.KAYE, Tacoma, Wash.  
Played Nazi marching songs, connected with Free Cuba Committee.  
CIA file, Internal Security Section and Disruption Agent.  
OSS/CIA, "extended agent" in State of Washington, then Oregon.

ERRORS OF THE 1978 JFK INVESTIGATION, PARTS CAREFULLY AVOIDED.

1. Assumption Lee Harvey Oswald guilty.No evidence he killed JFK or Officer J.D.Tippit.
2. Ignored the possibility of using silencers, common CIA weapon, used by Anti-Castro Cubans, DIA.
3. Marina Oswald motives for lying never exposed.
4. Attention directed from military and intelligence agencies closely linked to Marina and Lee: the CIA, FBI, Navy Intelligence, DIA, Defense Industry Security agents.
5. Motives for killing JFK avoided, other than "Castro revenge" or "Oswald was crazy".
6. The wrong witnesses were called. Richard Helms, E.H.Hunt and Frank Sturgis should be asked about Fred Crisman, CIA agent in Dealey Plaza.
7. Links of the Nazis to the assassination ignored.
8. The Torbitt Document, with long details on Permindex, the Pentagon, Anti-Castro Cubans, White Russians, Division V of FBI, and Church connections, never accepted by Blakey. Robert Blakey chosen as Chief Counsel to make sure the Torbitt Document never surfaced.Organized Crime links to all of this detailed in this manuscript.

CONTINUATION OF SIDE 1, PARTS LEFT OUT OF THE 1978 INVESTIGATION  
INTO THE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY.

10. Avoided adding up deaths of important witnesses, and what they could contribute to solve the puzzle if alive.
11. Ignored findings of their own selected witnesses.
12. Relied upon a parade of so called "respectables" to cover for lack of hard evidence. John and Mrs. Connally, Gerald Ford, John J. McCloy, John Cooper, L. Lee Rankin, and IBM atty. Nicolas Katzenbach.
13. Selected six incidences of Oswald's presence to refute "Oswald Double" evidence.
14. Maintained silence on Gerald Ford's CIA and Navy Intelligence contacts, only passing over his FBI informing to the Agency while on the Warren Commission.
15. Handwriting samples of Oswald's reduced to five or six for comparison, eliminating Marina's use of "Alec Hidel".
16. Left out the Chicago plans to kill JFK. Miami plans briefly mentioned, but Chicago assassination teams linked to an "Oswald" patsy and future FBI Cointel-Pro.
17. Mind Control. This 1978 investigation ignored the brain-washing of Jack Ruby, Marina Oswald. Ruby was with CIA agent Jolly West when he became "crazy" with Jewish fears. Marina Oswald went to Sedona, Arizona, with Priscilla Johnson, her CIA contacts, for her memory erasings and future control.
18. Jack Ruby contacts to CIA agent Warren Carroll, David Ferrie, Lamar Hunt, Dallas oil millionaires, Bertha Cheeck, sister of Erlene Roberts (where Oswald lived) all ignored. Ruby was coming into money, he was programmed to believe he would "be a hero". Links of promises and hypnotists, as well as Dallas connections, avoided.
19. Used scientific witnesses from NASA, Pentagon, named in Torbitt Document as being part of assassination teams. Conflict in using same men as Warren Commission in 1964.
