"Political assassins in Germany, secret armies, put a heavy burden on the administration of justice. The murderers had to be acquitted and the Victims had to be shown as guilty".

"No proof of illegal activity admitted in court".

DEFINITION OF "MALICE" THAT JURY DIDNT APPLY TO DAN WHITE

"Breaking the law in spite of an awareness that the act is illegal, doing it for a base and anti-social purpose, and with a wanton disregard for life."

Climbed through bathroom window to avoid detection.
Supplied with dum dum bullets, knows they are fatal.
Hits Mayor George Moscone in body, then to head.
Hits Supervisor Harvey Milk in body, then head.
Walks calmly out, calls wife, hand in hand to church.

NOVEMBER 1, 1978, REP. LEO RYAN WIRED JIM JONES, "COMING TO GUYANA".

NOVEMBER 1, 1978, DAN WHITE RESIGNED FROM BOARD OF SUPERVISORS

- Former policeman.
- Funded by hidden patrons.
- Mysterious traveling years.
- Armed with fatal bullets.
- Victim Moscone #1 on Jonestown hit list if Ryan goes down there, all will die.

CONFESSION, NOV. 27, 1978, IMMEDIATELY AFTER SURRENDERING TO POLICE, WHITE.
"S.F. Chronicle, May 4, 1978"

"Some of these people have charged me with taking money from big corporations and not recording it but I never did that. THEY were going to use me as a scapegoat. Whether or not I was a good supervisor was not the point. This was a political opportunity and they were going to degrade me, hang me out to dry."

THE DAN WHITE WITNESS THE DA DIDNT CALL, S.F. Chronicle, 5/23/79

JAMES DENMAN

James Denman, White's jailer, former undersheriff.

"White and Harvey Milk didnt speak to eachother since Milk voted for Youth Campus Mental Health Facility in White's district."

"Denman not called for political decisions".

"White's attitudes towards liberals and gays should have been brought in!" (would show malice)

"Denman saw White received with a reception not inconsistent with that fit for a hero" by S.F. Police.

JACK WEBB, CITY CHARTER COMMISSION, FORMER S.F. COP

"There was clearly some sort of a deal cut not to hit on the political aspects of this case."

Those were the Jonestown, S.F,
D.A. Freitas, Moscone connections.

BOTH SIDES BLAME S.F. POLICE, CHARLES GAINES .S.F. Examiner 5/24/79

1. The police waited 2½ hours, letting provoceteurs damage \$1,000,000 S.F. property. Stood and watched it, had Tac squads.

2. Started a riot after 11:30pm, physical damage, beatings, vengeance.

HOW THE COPS WADED IN ON CASTRO VILLAGE, S.F. Chronicle, 5/23/79

Came in cars, two or three in front and back.

Pulled up to Elephant Walk Bar.

Persons inside bar not at City Hall, not on streets.

Police armed with riot gear, helmets, sticks. "We lost at City Hall.

We aren't going to lose this one." Ten minutes of smashing.

Broken ribs, collapsed lungs, smashed heads, crashed bar, stools.

Cabaret!! Serpents Egg!! We give them the power and equipment.!!!

JUROR SAYS SYMPATHY FIGURED INTO VERDICT. S.F. Examiner, 5/23/79

"White sat like a robot during the three week trial".

"The jury, women favored, law enforcement background, important factor".

EDMUND KEMPER, WORK FOR BLIND, EARNS HIM TROPHY. UPI, 4/23/79

Murdered 8 people, IQ of 130, reading 1.75 million feet of tape.

Contributing to society, 2900 hours in past few years.

Psychosurgeon Hunter Brown wanted to do lobotomy on Kemper.

Dr. Peter Breggin threatened because he helped stop this surgery.
