Could the Kennedy family finally catch on?

Time-Life missed picture of the century, too bad.!

DIED THIS WEEK. ALEXANDRA TOLSTOY. Left USSR 1929, headed CIA foundation for Russian immigrants to preach anti-Communism. 95 yrs. old.

Paul Raigorodsky, Marina Oswald, George DeMohrenschildt and 28 other CIA links to Tolstoy foundation involved in JFK cover-up.

When Raigorodsky died, DeMohrenschildt left Dallas fast. Also died soon.

CATHERINE WRANGEL, Countess Catherine Lamsdorf (Russia) wife of Alexis Wrangel. 9/16/79, Cancer. Left USSR to France, USA in 1934. Powers model, N.Y.

Relative of George DeMohrenschildt, Alexis and George both Nazi agents. Husband headed Tolstoy Foundation in Middle East at time Sirhan family recruited via Nixon's friends in Whittier.

L.J. SNITZER, 59, Retired Officer of CIA. Cancer. 9/12/79

Worked in CIA in NYC, came to DC in 1960, senior officer.

Domestic Contact Services. Had to know James McCord, E. Howard Hunt.

Retired in 1973 when CIA purged of Watergate to JFK witnesses.

ROBERT E. BURGIN, 41, Investigator of Airplane Accidents, NTSB 9/12/79 Wash. Post. Auto accident, struck by oncoming car, N.J.

Graduate of USC, Investigator time of Watergate, other impt. crashes.

HERB CAEN, S.F. Chronicle. 9/25/79. Regarding fatal crash Atty. J. MacInnis.

Tape #407. S.F. District Attorney brushing off MacInnis murder.

This week. MacInnis supporting Freitas Challenger Joe Russonfiello for S.F. District Attorney.

Wash. Post, 9/10/79

\$20,000,000 missing, disbarred atty. from Fed. Pen., 1969-1979, reaching to Florida, Calif., Penn., Delaware, New York.

"Intense power struggle within church, bugging", Poland, Rome.
Rev. Zembrzuski, trip to Poland, Cardinal Karol Wojtyla of Krakow.
17 days after Karol Pope, all investigations called off.

Credit cards, checking accounts, secret investments, anti-Communist purposes between USA, Poland.

"KIDNAPPED BANKER COST VATICAN A FORTUNE" UPI, S.F. Examiner 8/12/79

Meetings with Pope Paul VI and Sindona, 1969.

99 count indictment, USA. "Misusing \$45,000,000. Franklin Natl. Bank.
Vatican losses under Michele Sindona \$46,000,000 up to 1975.

"SINDONA INQUIRY BY ITALIAN PARLIAMENT GETS SUPPORT" NYT, 8/10/79

"Linked to Slayings, several murders."

Giorgio Ambrosoli, Milan lawyer and Boris Giuliano, police, Sicily.
Discovered large-scale smuggling of drugs from Sicily to USA.
Linked to Sindona, Vatican banks. Money washing, laundering.

"FINANCIER'S DISAPPEARANCE QUESTIONED", AP, Milan, Italy, 8/15/78

Urged former U.S. Ambassador to Italy, to clarify secret American funding of Italian political parties through Sindona-Vatican banks.

"It is a case of economic criminality in very specific circles".
Graham Martin former U.S. Ambassador (Henry Cabot Lodge, Clare Luce)

"LAW FIRM IS INDICTED IN VISA FRAUD". NYT, 6/1/79

Former Carter envoy to Vatican, David M. Walters! Came back when conspiracy indictment by Fed. grand jury. Law office used for 34 alien visas, clients from Europe, Asians, Latins.

Arrangements made with State Dept. agent Mr. A. Stephan Vitale, who then went to work for Walters and Sarino R. Costanzo.

Worked through U.S. Embassy, Nassau, Bahamas. Where else? Drugs, \$\$\$ washing.

"DRUG TESTS STILL BAFFLE VETERAN!" S.F. Chronicle, 9/26/79 Tests in 1973.

"Trying to determine whether these drugs could be put into bombs and scattered among troops, and used to incapacitate them so they could just be herded into pens and our guys could just run around and pick up their weapons." Chris Roop

"NAVY FOGGED BAY AREA WITH BACTERIA!" PNEUMONIA CLOUD OVER CITY. 9/17/79

WP. Tests between 1949 and 1969.

239 different occasions.

Tested in Wash., N.Y., Key West, Panama City, Florida, San Francisco
Aerosol released. So was bacteria known as serratia.

Grandfather of Legionnaires Disease and Swine Flu.
