"GANGLAND WAR IN PORNO BUSINESS", Jack Anderson, 2/26/80 WITNESS GONE

Michael (Mickey) Zaffarano, FBI to arrest, links of DC, NY, La
Cosa Nostra in USA, Gambling, narcotics, pornography. FBI MIPORN.

"DEAD MAN ACCUSED IN 3 BEVERLY HILLS SLAYINGS" SJM, LAT 2/27/80

Belgian businessman, Eric Arnold (Arne) Tali, pharmaceutical
competitor with Lloyd Cotsen. "Killed" Cotsen's wife, son, friend,
left Cotsen free to find him. When B.H. Police appeared, he
"apparently" committed suicide. Killed, "alone", the three. These
deaths when BRILAB, ABSCAM, and 90 investigations started. Beverly
Hills Sweeney Todd goes to Europe to find their man. Case solved.

HUNTING SEASON FOR WITNESSES. SHADES OF NAZI COURTS.

"ANTIQUES DEALER, ASSISTANT KILLED ON EAST SIDE", NYT, 2/23/80

Richard M. Kallman murdered. Assistant "Steven" not identified in media. No last name? Not part of ABSCAM? Valuable oil paintings, art treasures, sold from private residence. \$2.3 million Titian there, "some believed missing". Question; ANY RUBENS, VATICAN GIFTS?

"ARIZONA COURT REVERSES CONVICTIONS IN DON BOLLES SLAYING". UPI, 2/26/80

Don Bolles, reporter, killed by organized crime, "Emprise" June 1976. Max Dunlap, James Robison, sentenced to death, had case reversed. "Trial judge frustrated defense attorneys". Most Arizona judges put into office by the mob. Good way to blow the case. ABSCAM AND BRILAB BEGAN WITH ARIZONA, PHOENIX CASES.

"JOSEPH B. COLLINSON, TEXTRON'S CHAIRMAN", NYT, 2/23/80 QUIET DEATH

"Took over from G. William Miller as S.E.C. Began Investigation" Named Chairman when Carter nominated Miller to Federal Reserve. Own Texas based Bell Helicopter, Nazi Walter Dornberger in charge. Collinson would have to testify if Miller taken to court on pay-off. Another primary witness, "apparent heart attack". 65 yrs old.

"E.C. Jaegerman, Ex-S.E.C. Aide", NYT, 2/21/80 ANOTHER DEATH BEFORE TRIALS

"Apparent heart attack. 67 yrs old. Appointed to S.E.C. by William O. Douglas, later Justice of Supreme Court. Under investigation with Texas Gulf Sulphur case. Never to court. Brokerage firm he joined, accused of various violations. Never tried. "Not resolved" Impt. Wall Street, SEC pals, came to his assistance.

"GEORGE BERDES, CONGRESSIONAL COMMITTEE ON JONESTOWN", AP, 5/19/80

"There are 120 white brainwashed assassins out from Jonestown awaiting the trigger word to touch them off".

WHO WOULD JONESTOWN ASSASSINS KILL? Anybody who knows how Jonestown was formed, its role with CIA, Mind Control programs of Mk-Ultra, the State Department, and Prime Minister Forbes Burnham's CIA puppet government, has to be killed if they start to talk.
