### PURPOSE OF SUIT

"The EPA has not considered the dangers of releasing a novel organism into the atmosphere. They did not require any toxicology tests to determine the possible affect on human beings by the bacteria".

"The damage would be catastrophic and irreversable if the tested bacteria, genetically altered, become competitive and dominate".

"Any experiments that release genetically engineered microbes into the environment should be conducted in remote locations and away from people or crops".

PERMIT CONDITIONS FOR TESTING GENETICALLY ALTERED, LIVE BACTERIA

1. All treated crops must be destroyed or used for research. Use "PROPANE TORCH" and debris will be disked into soil.
2. EPA must notify property owners at least 15 days in advance, if nearby.
3. AIR SAMPLES will be carried out, EPA observer authorized.
4. Monitor on a monthly basis for one year the test field.
5. Permits for EPA, State Agric., experiments CONDUCTED PRIVATELY.

SECRETS, METHODS

1. 2 acre plot, center of 1 acre parcel.
2. SECRECY, "dont want a LOT OF PEOPLE WATCHING, THEY WILL REVEAL SECRETS"
3. Workers will wear FULL PROTECTIVE CLOTHING, WHOLE BODY WATERPROOF SPRAY SUITS, HATS, GLOVES, BOOTS, GOGGLES, RESPIRATORS".

FIRST TIME PROJECT FOR USA, THE WORLD.

AGS will release INTO THE OPEN ENVIRONMENT, FOR THE FIRST TIME, organisms made in the labs, developed GENETICALLY, ALTERED STRAIN OF bacteria. Called FROSTBAN.

THE DANGERS, CONCERNS OF CRITICS.

1. AFFECT ON WEAK IMMUNE SYSTEMS, INFECTIONS FOR CANCER PATIENTS or "OTHER SICK INDIVIDUALS" Pseudomonas syriangae, Pseudomonas fluorescens. "Pseudomonas flouescens might be marginally pathogenic in individuals with poor health, "weak immune systems" .Under special conditions can develop infection in cancer, other sick patients."
2. COULD DAMAGE WEATHER, RAINFALL . "Potentially catastrophic reduction in worldwide rainfall. P. syringae bacteria and the frost they attract, an importance source of particles around which water vapor, raindrops fall", Jeremy Rifkin. "ALGENY", by Jeremy Rifkin, "LANDMARK FOR BIOTECHNOLOGICAL AGE" "This is an INSANE experiment to carry out in rich agricultural region"
3. FEAR BACTERIA WILL SPREAD BEYOND TEST PLOT, SUPPLANT NATURAL BACTERIA.
4. IF BACTERIA SPREADS, IT WILL BE UNCONTROLLABLE.
5. PROXIMITY TO OTHER PROPERTIES, POPULATION, NEARBY NEIGHBORHOODS.
6. LOCATION KEPT SECRET FROM WALTER WONG, COUNTY ENV. HEALTH OFFICER.
7. EPA PERMITS STIPULATED TESTS SHOULD BE IN "ISOLATED AREA"
8. SECRECY. BOARD OF SUPERVISOR SAM KARAS, "READ ABOUT IT IN NEWSPAPER".
