INTELLIGENCE ADVISER AND "THE GREEN BOOK AFFAIR" (continued from #347)
Washington Post, Sept.16,1976

- "Lost in Europe, March, 1975," the list of 100 or more agents.
- "Classified information, injurious to National Security of USA".
- "Cmdr. Lionel H. Olmer, 19 years navy career, extremely meticulous".
- "July 24, 1975, Michael James Casey, 'I have your notebook'".
- "Eighteen month ordeal".
- "Casey recovered it from SYMPATHIZERS OF PATRICIA HEARST".
- "The notebook to be used, EXCHANGED FOR CONSIDERATIONS" on her behalf." Working on Judge Carter.
- "Casey sought to appear at her trial on charges of bank robbery" but ended up, instead, working for CIA, Cherne, INTERNATIONAL RESCUE COMMITTEE.
- Casey employed by IRC August 22, 1975.

CINQUE, DONALD DE FREEZE, "DIDNT KILL HIMSELF"
United Press, May 22, 1975

Dr. Ronald Taylor, director of forensic laboratories in the L.A. coroner's office. Dr. Vincent Guinn, chemist at Urvine, U.C. campus.
"It looks to us like DeFreeze was killed with a nickel plated, steel-jacketed bullet". "We received further information that AT LEAST ONE MEMBER OF THE LAPD SWAT TEAM MAY HAVE FIRED A DIFFERENT KIND OF AMMUNITION THAN WE RECEIVED IN THE INITIAL SAMPLES."

Was that "one member" FBI agent Donald Gray?

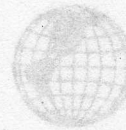

 Cherne Vice-Chairman of Democrats for Nixon,1972.

1970-1971, Nixon planning "Operation Chaos", CIA, DIA domestic attack against organizations named during SLA spree.

Leo Cherne, May, 1963, formed Freedom House, "Citizens Committee for a Free Cuba". Nov.22,1963, President Kennedy assassinated, Anti-Castro Cubans involved.

Cherne on Board of Hudson Institute, Director Herman Kahn

HERMAN KAHN, SPEECH TO INTERNATIONAL POLICE, LOS ANGELES POLICE DEPARTMENT
 Los Angeles Times, Oct.11,1976

One year after LAPD, Swat teams, murdered six SLA members, including their own agent, Donald DeFreeze.

Kahn told them that such "values" as "safety, health, ecology, environment, social justice, security, and quality of life are fine, but you cant run a country on them."

"We are going to a conservative turn. Square values, square politics."

"Charles Manson and Lynnette Squeaky Fromme were victims of hysteria. Supression of evidence in the Fromme trial would have been enough to declare a mistrial if Fromme hadnt been a Manson girl."

WALTER SCOTT'S STRANGE STORY

"Walter was a computer specialist who worked for Washington firms with government contracts. He was a paid informant for the FBI and various U.S. Intelligence agencies".

"Walter Scott made an anonymous call to Scranton, Pa. police to say where the fugitive SLA were housed."

WALTER SCOTT, Nov.29,1975, THREE MONTHS LATER. UPI

"Scott voluntarily admitted himself to the hospital for mental observation. In Southern Nevada Memorial Hospital, psychiatric ward."

WALTER SCOTT, October 3,1975, Earth News.

Scott worked as a "hit man" for the National Security Agency"
 "I get contracts for killing people, I've been doing it for 8 yrs."
