The House Select Committee on Assassinations has gone substantially beyond the findings of the Warren Commission and has concluded that a conspiracy, perhaps by organized crime, led to the assassination of President Kennedy, according to sources familiar with the committee's final report.

After spending 2½ years and \$5 million, the committee says in its final report, to be released soon, that the conspirators may have included organized crime figures, Cubans and James R. Hoffa, former president of the International Brotherhood of Teamsters, according to the sources. But a source close to the committee said the investigation did not produce "a smoking gun."

"There is no evidence of a meeting where the murder was planned, there is no account of the details of the plot," the source said. "There is a substantial body of evidence, a web of circumstantial evidence, to connect the death of the president to elements of organized crime. Not to a national crime syndicate, nor to one individual."

About six months ago, the committee presented accoustical evidence it said showed that two gunmen had fired at the presidential motorcade as it made its way through Dealy Plaza in Dallas in November, 1963. But three members of the committee called the

WITNESS TO TRIAL OF 17 KKK MURDERED IN PARKING LOT. Assoc. Press 6/6/79

Birmingham, ALA. Loyal Newton Bailey, 49, dead, blunt instrument injury.
U.S. Attorney J.R. Brooks "No evidence linking the death to the trial".
Sgt. W.T. Gaut, "Robbery ruled out as a motive. Watch, money still there".
Primary prosecution witness on use of a weapon to intimidate blacks.
Judge ordered the "jury sequestered for the duration of the trial
so they will not know about the murder until trial is over".

Prosecution proceeded with "opening arguments" the day main witness
killed.

L.A. STRANGLER, 14 women killed, 2 students then killed, Bellingham, Wash.

Murders started Sept. 9, 1977, last murder Feb. 17, 1979.

Lawsuit, March 6, 1978, Bethe Anne Shannon, \$1,000,000 against LAPD.

Two officers tried to pick her up. She got away.
They said they were the "strangler."

KENNETH BIANCHI, Now in Bellingham, Washington.

Two personalities, Steve Watkins did the killings (like Candy Jones?)
Former security guard from Rochester, New York. (loser in New York)
Moved to LA late 1975. No past training, formal education. Moves up.
Worked for Calif. Land Title Co, Universal City, L.A.
Sudden change of personality, money, confidence, advanced training.
Carried Police Captain's badge, identification from Calif. Highway
Patrol, handcuffs. Said he was "doing undercover work for LAPD."
Diploma in his office, Columbia University, PHD. Psychologist.
Offices provided, Dr. Charles J. Weingarten, North Hollywood, in
Federal Savings Building, near Calif. Land Title Co.
LAPD knew of him LONG BEFORE many murders, "never followed",
Chief of Police Daryl Gates. (Successor to Ed Davis)
