That explains how he got the Russian Language guides.
This was not two people in two different places, but one person
with paper work shifted, knowing he was not where they reported.

Nelson Rockefeller, CIA links with A. Dulles, John J. McCloy, others, named by Donaldson, died Feb. 1979.
